Blessings as you continue on this Lenten journey, as together, we seek the tiny spark of Light and move as Pilgrims of Hope to the full truth of our calling, that of embracing Transformation.


When the Board members meet in June, they will approve the new Direction forward and share these with their communities and beyond.



STATIONS OF THE CROSS

We invite you to take a reflective walk through our newly renovated Stations of the Cross at St. Theresa's Garden. We warmly welcome everyone to this beautiful setting, hoping it provides an opportunity for prayer or contemplation.

The Stations of the Cross were first erected in St. Theresa's Garden in July 1941, shortly after the Novitiate Sisters created the garden. Over the years, they have undergone several modifications, most recently receiving a fresh update. Art conservator Michelle Gallinger has meticulously restored the stone plaques depicting the stations, while Todd Vassallo of *Projectworks Artistry* replaced the wooden crosses with more durable, weather-resistant aluminum. The large Crucifix, requiring more extensive restoration, is expected to be installed in the near future.

Milestone jubilees and anniversaries have always been joyously celebrated by the Marthas. Three occasions in particular stand out: Golden (1950) and Diamond (1975) Jubilees and the Centenary (2000).

1950: GOLDEN JUBILEE

The 50th Jubilee marked a significant milestone for the thriving and well-established Congregation, which boasted a successful community life and a dedicated group of 283 hardworking professed Sisters—homemakers, nurses, health professionals, administrators, teachers, and social workers—along with a growing number of Novices.



Photos: A cover and a page from the Golden Jubilee Pamphlet, 1950 A special celebration took place on Jubilee Day, with plenty of visitors coming to Antigonish:

"A Pontifical High Mass was held at StFX University Chapel, Pope Pius XII sent a congratulatory message, special dinners for clergy and visiting sisters were held and a portrait of Bishop John Cameron was uncveiled at Bethany." (And Martha Served: p. 186).

More events followed such as a special mass for the deceased Sisters, a procession to the cemetery, a reception at Bethany for family and friends. The Marthas received letters, cards, and telegrams from well-wishers—sister congregations, expatriate clergy, professional associations, and the Antigonish town mayor. The Casket, Halifax Herald, and Sydney Post published special eulogies. The Congregation itself honored their Superior Mother Ignatius with a trip to Rome and an audience with Pope Pius XII.

"The jubilee year aptly marked the conclusion of an eventful fifty years for the Sisters of St. Martha. As a community that had overcome many obstacles and

challenges, as well as experienced numberless opportunities and blessings, they had much cause for celebration. The jubilee itself evoked reflections on the path they had traced together.

ANNIVERSARIES AND JUBILEES OF THE PAST

1975: DIAMOND JUBILEE

In 1975, the Sisters of St. Martha embraced their spirit of joyful celebration as they marked their Diamond Jubilee. The "Martha Committee '75 carefully planned various events that

would bring together Sisters from 29 different

communities living across Canada and the US. While individual houses held their own commemorations, the main events took place in Antigonish, NS: "Busy Bethany witnessed receptions, barbecues, masses, ceremonies, an open house, and a variety concert, while congratulations poured in..." (And Martha Served, p. 288)

Besides numerous celebratory events, every anniversary was an occasion for deep reflection on the Congregation's history, memories, and present reality, inspiring engaging and memorable initiatives. One such endeavor for the 75th Jubilee was taking steps to preserve the Martha

history. The first congregational archivist was appointed in 1974, and in 1975, Sister May Mulvihill became the congregational historian.




As part of Jubilee opening events hosted on July 16th, 1975 by StFX University, "the cradle" of the Congregation, a memorial plaque was unveiled at the original motherhouse on campus. The inscription reads:

"Here in the original motherhouse of the Sisters of Saint Martha founded at Antigonish in 1900, Saint Francis Xavier University proclaims profound gratitude to a valiant company of religious women for their gracious presence and selfless service to its priests, professors and students."

written by Dr. Patrick Walsh of StFX, acted by Marthas and friends, and filmed by the National Film Board.

The Jubilee was also commemorated with a special edition of the internal newsletter *The Bethanite*, a wonderful source of Martha stories.





On July 12, 1999, over a hundred Marthas traveled to Halifax for a Ritual of Remembering with the Sisters of Charity. They gathered at the site of the old Motherhouse, where the pioneer Marthas had once lived alongside the Sisters of Charity. Fifty Sisters of Charity then joined the Marthas in Antigonish, where they held a brief prayer at the first Motherhouse on the StFX University campus (photo above). This shared experience began the process of deepening the Marthas' understanding of their common roots in the charism of charity.

Photo: The Marthas participated with the people of Antigonish in the Highland Games parade, both in 1999 and 2000. A float in 1999 featured a four-tier cake replica and highlighted their four apostolates.

ANNIVERSARIES AND JUBILEES OF THE PAST

2000: CENTENNIAL

The Centennial, celebrated with numerous events and undertakings for the entire year, was very special for the Marthas, a true gift.

On July 16th, 1999, Sr. Yvonne Vigneault opened the Jubilee Year at the Bethany fountain with a proclamation, followed by trumpet fanfare, a water ritual, and a procession to Bethany. A defining moment came as she declared, "Let the doors be opened", inviting all into the chapel for the Eucharist. On July 29th, the new Governance Team was installed, and each Sister received The Martha Wisdom Book, a compilation of prayerful Martha insights to mark the occasion (available on our website).

As a special project, Dr. James Cameron was commissioned to write And Martha Served, a popular history of the Congregation, an idea of Sr. Irene Doyle. On the day of the book launch, each Sister received an autographed copy.

MARTHA MEMORIES IN OBJECTS

Heritage Place at the Bethany Motherhouse

Heritage Place officially opened on September 21st, 1999, on the second floor of the middle wing of Bethany Motherhouse. When the Marthas moved out of Bethany in 2018 and the building was deconstructed, some items from Heritage Place were relocated to the Heritage Gallery in Parkland Antigonish, while most found a home in the private Archives at Bethany Resource Centre.

The establishment of Heritage Place was a unique project to mark the 100th Anniversary of the Sisters of St. Martha in the year 2000. In 1987, Sisters M. Reginald MacKinnon, May Mulvihill, and Jean Morrison of the Bethany Archive Staff proposed establishing a heritage space at Bethany, highlighting the need for a clear purpose, defined audience, suitable location, and appointed curator. While the request remained ongoing, securing an appropriate space proved challenging.

Starting in 1987, study and planning meetings involving several Sisters and

a "Space Committee" took place, with extensive contributions from Sister Mary Roderick MacMullin. In 1996, Sister Simone Roach was appointed Director of Heritage and, despite having little prior experience, undertook the task of establishing Heritage Place for the Sisters of St. Martha's centenary in 2000. She modeled it after the IHM Heritage Museum in Munro, Michigan and consulted Chris LaVerne of the Nova Scotia Museum on key design elements. Gerald MacIsaac ensured these recommendations were implemented, and Pierre Morrell crafted the display cases.

OUR MARTHA VALUES

The power of a Founding Story

In the previous issue of OLaM magazine, we explored the value of "living a joyful life", a principle deeply woven into the fabric of Martha community life. Recreation and celebration have long played a vital role in nurturing community bonds. However, an even more powerful force in strengthening these connections is the shared foundation of common stories. For the Marthas, this begins with their Founding Story—a defining moment of courage and faith.

Widely known Congregation's Founding Story of "the fifteen women who stood up" was not always the dominant one. At the time of the Golden Jubilee in 1950, the late Bishop John Cameron of Antigonish Diocese was officially recognized as the sole founder of the Congregation and was honoured with an oil painting and a special biographical sketch of his life written by Sister John Baptist, distributed to local houses (And Martha Served, p. 191). The contributions of Bishop Cameron, Dr. Daniel A. Chisholm—a steadfast supporter of the Sisters—and the First Formators, the Sisters of Charity of Halifax, were instrumental in the Congregation's establishment. Without Bishop John Cameron, the Congregation would not have come into being. Yet, it was equally dependent on the courage and commitment of the 15 Founding Women.

On July 12th, 1900, thirteen Sisters stood up to indicate their choice when, at the request of Bishop John Cameron, Archbishop O'Brien of Halifax called for volunteers to leave the Sisters of Charity and establish a new religious order in Antigonish. Two

Sisters who were not present stood up figuratively – they expressed their wish to go to Antigonish too, bringing the number of volunteers to fifteen. Mother Faustina MacArthur, one of the Founding Marthas, later recounted the pivotal moment when the volunteers rose, marking the formation of the new Congregation:

"I heard her standing but I did not know who stood. The Sister to my left stood next. Then I stood, I just felt I had to get up. I had no previous notion of volunteering for anything."

These words are precious for each Martha and the defining moment of standing up, whether physically or figuratively, is now recognized as the Congregation's Founding Story. The fifteen women were publicly declared as Founders in 2000, with Bishop John Cameron being now considered a cofounder.

That significant shift in the perception of historical facts allowed for a deeper sense of belonging and purpose, uniting Marthas across time. The powerful symbolism of standing up conveys *courage*, *commitment*, and *solidarity*. When the Founding Women of CSM stood up, they





made a bold and visible choice to walk into an uncertain future, individually and collectively demonstrating their *faith*, *resilience*, and *willingness to serve God*.

In embracing the full story of the founding moment, the Marthas allowed the memory of that one July day long ago to become a source of strength, finding in it both inspiration and a call to action. The symbolic act of "standing up"transformed into a tradition of standing together—for one another, for those in need, and for justice.

The power of Martha Founding Story continues to propell the community into new endeavors, allowing for openness and a welcoming attitude towards the new and the challenging.

In February, in my role as the Marthas' UN NGO Liaison, I was privileged to be a delegate at the United Nations Commission for Social Development at the UN Headquarters in New York and it was a wonderful experience!

This annual event brings together country representatives from around the world to focus on social policy needs and initiatives. The priority theme for this year's Commission was enhancing solidarity, social inclusion and cohesion to advance the goals of the Copenhagen Declaration, the World Summit on Social Development, and the 2030 Agenda for Sustainable Development.

THE ROLE OF **CIVIL SOCIETY**

MORAL COMPASS: Guides governments with ethical principles

ACCOUNTABILITY: Ensures governments uphold their commitments

COMMUNITY IMPACT: Plays a key role in implementing social policies

It is always important to ensure the voice of civil society is present at the Commission and other UN events. It allows grassroots groups to share their voices in guiding discussions forward.

This year, our Sisters of Charity Federation group —including NGO Representative Jimmy Walters, NGO Liaisons and Communicators from each member congregation— was the largest civil society group at the Forum!

CIVIL SOCIETY FORUM

Civil Society Forum is a scheduled part of the Commission that is led and organized by civil society groups and offers space to raise concerns and share initiatives. This year, discussion focussed on the importance of social protections for individuals lacking support—such as those unemployed, in informal work, or without adequate or any social benefits or programs.



CIVIL SOCIETY DECLARATION

In advance of the Commision, non-governmental organizations come together to develop a Civil Society Declaration, stating the concerns shared by civil society on the progress of social policy, particularly considering the UN Sustainable Development Goals (SDGs) and Agenda 2030.

The declaration also offers specific **Calls to Action** for the Commission as it develops its resolutions, which will inform the coming World Social Forum in Doha later this year. The Declaration was signed by over 1000 individuals and groups.



CALLS TO ACTION:

1. EQUAL ACCESS FOR ALL

- **♦** Healthy and safe environment
- **♦** Affordable housing
- **♦** Affordable nutritious food
- Quality healthcare
- **Basic income**
- Public services: water, sanitation, energy, financial services and digital access


HEALING THE DIVIDE


Martha Justice Ministry hosted a free public education series HEALING THE DIVIDE: A JOURNEY OF RECONCILIATION

ORCIE WEBINAR AND WEBSITE



On March 18th, the Office of Religious Congregations for Integral Ecology (ORCIE) offered, as part of the Jubilee 2025 From Debt to Hope campaign, a webinar "From Ecological Debt to Ecological Hope", led by Sr. Sue Wilson, CSJ, ORCIE Board Chair.

Sasquia Antunez Pineda, ORCIE's Advocacy & Communications Officer, provided background on the link between ecological debt and global financial exploitation, emphasizing how poorer countries of the Global South are being hit hard, as they are forced to pay back debts to rich countries – the result of structural financial exploitation. While repaying unjust debts, they are unable to fund essential services like health care or social policies, along with being unable to respond to ecological and climate impacts.

Brazilian speakers, journalist Elton Bozzetto and Sr. Nilva Dal Bello, CSJ shared stories of communities in Brazil harmed by international industrial polluters. We also heard about the important work of religious congregations in supporting these communities in their struggles for justice and speaking out in solidarity.

TAKE ACTION! JUBILEE 2025: TURN DEBT INTO HOPE

As part of the Jubilee Year, a global campaign called TURN DEBT INTO HOPE has been launched calling for countries to initiate a process of financial debt forgiveness and compensation for ecological debt to countries made poor by exploitation.

KAIROS is leading the ecumenical campaign in Canada, organizations like Development and Peace - Caritas Canada, the Office of Religious Congregations for Integral Ecology (ORCIE), and the Canadian Council of Churches supporting the campaign. As Kairos explains,

Throughout history, Jubilee years have been a call to restore justice by cancelling debts, caring for people and the land, and addressing inequality.

Today, forty percent of the world's population is living in countries that are forced to spend more repaying debts than on health, education or tackling the climate crisis.

PILGRIMS OF Meanwhile, wealthy corporations countries, including Canada, and exploit resources from heavily indebted nations and Indigenous Communities causing human rights violations and severe ecological harm. This creates an "ecological debt" owed to those countries and to Indigenous Peoples.




Braiding Sweetgrass for Young Adults: Indigenous Wisdom, Scientific Knowledge, and the Teachings of Plants.
